## **Library Director's Report January 2020**

### **Library News and Programs**

Tomorrow, Jan. 15<sup>th</sup>: Afternoon Movie: "Downton Abby" with Tea & Scones!

I am working on our February Lunch & Learn: I have requested a speaker from Madison for a talk on "The Scandinavian Recipe for Happiness". I should be hearing back soon!

Northwood's Book Festival: We had our first meeting. We are looking at getting Michael Perry for Presque Isle, in honor of Jim Battin at Ramona's suggestion. I ran it by the other librarians, as I wanted to be sure we haven't booked him too much as a festival. It turns out; the Festival has only had him once. ### **Computers**

Computer usage had decreased dramatically. Our public use computers had a count of 1048 in 2018. In 2019, it has decreased to 678. This is 370 less. When we were looking at patron count over 2019 (last month), I think this number can directly point to less patrons coming into the library to use computers. It makes sense that people are probably getting fast speed internet in their homes and don't need to rely on the library as much. Going forward, we may decide to decrease the number of computers we have.

### **Amazon Annual Report/Coontail**

As you can see from our Treasurer's Report, our Amazon numbers have decreased steadily. I have tested our link on the Amazon Associates website and it is still working (I did this last year, too). I have confirmed our website (I did this last year, too) to make sure there isn't old information informing the numbers. We will see what happens. It could be that there are so many Amazon Smile accounts, we are just seeing less going towards the library. It could be that Amazon has lowered the percentages awarded for certain purchases.

On the bright side, patrons are turning in their Coontail receipts and we received \$11 in January for the library from purchases made at Coontail! If you shop there, just write #11 on the back of your receipt and put in the big wooden box by the entrance (gas receipts do not count).
