Total Collection - decreased 4,129

2016= 25,701 2017= 21,572 (including adding 1,362 new items)

This MAY decrease our collection numbers in the system from 4% to 3% It depends on what the overall system looks like for collection data. This MAY save us roughly \$500 in 2019.

Total Annual Circulation-not including e-books -decreased by 39

2016 =11,101 2017= 11,062
