# Opening the Library & Onboarding Volunteers

Opening the Library – The plan is to open on Mondays, Wednesdays, and Fridays on May 17<sup>th</sup>. Fully opening is planned for June 7<sup>th</sup>. By June 7<sup>th</sup>, we will be able to have groups in the library again. Mahjong, Material Girls, Book Clubs and Knitting Club have all been contacted with this date in mind.

Onboarding Volunteers - We currently have a full schedule of volunteers. I have refresher "sessions" scheduled to reorientate the volunteers and to inform and train on new things that have come up in the past year. I also used this opportunity to train on new things like creating a library card and a "troubleshooting" training. The idea is to be able to leave volunteers more on their own so Sarah and I can take a lunch break and/or get work done. Another reason is for Sarah and I to be able to take time off.

# a. Summer Programming and Library News
